_____ **Taxes & Permits:** Vendors are responsible for obtaining any required **Missouri sales tax license**, collecting and remitting applicable sales tax, and obtaining any other licenses, permits, or approvals required for their business or products.

_____ **Liability & Property:** Vendors are responsible for their own merchandise, equipment, displays, and personal property. MidMo Makers Market, Show Me Hope TNR, the venue, and event organizers are not responsible for loss, theft, or damage to vendor property.

_____ **Vendor Responsibility:** Vendors are responsible for the safety and stability of their booth, displays, signage, cords, equipment, and merchandise and must maintain their space so it does not create a hazard for attendees or other vendors.

_____ **Electricity:** Vendors purchasing electrical access must provide their own appropriate extension cords and/or power strips and keep cords safely secured within their booth area or as directed by event staff.

_____ **Booth Space:** Vendors must remain within their assigned booth footprint and may not block aisles, exits, neighboring booths, or designated access areas.

_____ **Booth Sharing / Transfers:** Booth spaces may not be transferred, resold, shared with another business, or otherwise reassigned without prior approval from the Market Coordinator.

_____ **Event Hours:** The market is open to the public from **10:00 AM-4:00 PM**. Vendors are expected to remain set up and open for the full event unless an emergency occurs or prior arrangements have been approved by the Market Coordinator.

_____ **Setup & Breakdown:** Vendor setup begins at **8:00 AM**. Vendors may not begin dismantling before the market closes at 4:00 PM except in an emergency or with approval. All merchandise, displays, equipment, trash, and personal belongings must be removed by **7:00 PM**.

_____ **Conduct:** Vendors are expected to conduct themselves professionally and respectfully toward attendees, other vendors, venue staff, and event organizers. MidMo Makers Market reserves the right to require removal of a vendor whose behavior or booth creates a safety issue or substantially disrupts the event.

_____ **Compliance:** Vendors agree to follow applicable venue rules, fire and safety requirements, and reasonable instructions from the Market Coordinator during the event.
